Applicants must provide valid copy of I.D. & C.I.B.

Be sure to include:

- Completed Eagle Feather Application
- photocopy of state issued identification (Driver's License)
- photocopy of Certificate of Indian Blood (C.I.B)

**Please Note: You may apply for a <u>maximum</u> of two (2) Long Feathers (Tail and Wing) per year; one (1) of which may be a Tail Feather. Apply for:

- 1 Tail and 1 Primary or Secondary Wing Feathers; or
- 2 Primary Wing Feathers; or
- 2 Secondary Wing Feathers; or
- 1 Primary and 1 Secondary Wing Feathers.

All applicants receive 2 Body and 2 Plume Feathers.
